INVITATION TO PARTICIPATE IN THE ANNUAL CAPACITY ALLOCATION PROCEDURE AT HAMINA LNG TERMINAL FOR THE SERVICE YEAR 2026 (01.01.2026 – 31.12.2026)

Hamina LNG Oy invites the market participants to participate in the Annual Capacity Allocation Procedure at Hamina LNG Terminal for the Service Year 2026 (01.01.2026–31.12.2026). During the Annual Capacity Allocation Procedure, Hamina LNG Oy will allocate Terminal's available capacities for the Storage Service and the Regasification Services in accordance with the principles described in the Terminal Rules for Hamina LNG Terminal and the Terminal Allocation Request Form published on Hamina LNG Oy's website.

The market participants are invited to request capacities for storing LNG in the Terminal's LNG tank (the "Storage Service"), and for the Terminal's regasification and injection services (the "Regasification Services"). The service capacities are allocated in "Slots". For the Service Year 2026, the Available Slots at the Terminal are as follows:

300 Slots for Storage Service, where a Slot equals to 650 MWh of LNG (≈ 100 m³)

• 6000 Slots for Regasification Service, where a Slot equals to one (1) MWh/Gas Day.

Bio LNG / Sustainable Inventory Services: In addition to the above, Hamina LNG offers the Services as "Sustainable Inventory Services" for Bio LNG. The Terminal's storage tank is certified under the ISCC EU certification system, enabling Bio LNG handling as Sustainable Inventory, with separate bookkeeping to preserve sustainability status upon redelivery. Applicants intending to utilize Bio LNG must provide a valid Certificate of Sustainability.

Within the Annual Capacity Allocation Procedure for the Service Year 2026, the market participants may also apply for capacities for the Storage Service and the Regasification Services for the Service Years 2027 – 2029. The capacities for the Service Years 2027 – 2029 are allocated for the willing Applicants for the requested Service Years if, and to the extent, the Annual Capacity Allocation Procedure for the Service Year 2026 results in a Binding Allocation.

The Annual Capacity Allocation Procedure is confidential and will be conducted in accordance with the Terminal Rules of Hamina LNG Terminal. The Terminal Rules and the associated price list are available on the Hamina LNG website.

The Annual Capacity Allocation Procedure begins on 15 October 2025 and the applicants must submit binding applications by 1 December 2025 in order to be considered in the Annual Capacity Allocation Procedure. As a result of the Annual Capacity Allocation Procedure, Hamina LNG Oy shall confirm the accepted Service Capacity allocations by 8 December 2025 and the mutually binding Terminal Services Contracts are expected to be signed with successful applicants by 15 December 2025.

Hamina LNG reserves the right to modify the timetable during the process with direct notification to all participants. Please contact info@haminalng.fi if you have any questions throughout the process. More detailed description of the process and timetable is as follows:

- 1) In order to be considered in the Annual Capacity Allocation Procedure, please send the following documents by 1 December 2025 to Hamina LNG's email info@haminalng.fi with the subject "Hamina LNG Open Season application documents"
  - a) Filled and signed <u>binding</u> Terminal Capacity Allocation Request form, which is published on Hamina LNG's website as appendix 2 of the Terminal Rules.
  - b) Copies of the passports or id cards of the signatory or signatories of the Terminal Capacity
    Allocation Request Form, and evidence of these persons' authorization to submit the
    application with binding effect for the applicant
  - c) Copy of registration certificate, issued according to the law of the jurisdiction in which the applicant is established, and the articles of association or other founding documents
  - d) Audited financial statements from the last three (3) years or, if the company has been founded more recently, since the founding of the company
  - e) Written confirmation that the applicant has the necessary LNG procurement channels and vessels suitable for delivering LNG
  - f) Information on whether the applicant is a registered user as defined by the Finnish Tax Administration, and if so, a copy of the documentation evidencing such status



- 2) After the application period, Hamina LNG will process the applications submitted by 1 December 2025 and request possible rectifications for the deficient applications.
- 3) The available Slots for Service Capacities are allocated among the applicants in accordance with the principles provided in the Terminal Rules, and Hamina LNG will inform the applicants of the accepted capacity allocations 8 December 2025.
- 4) The Terminal Services Contracts shall be signed with successful applicants 15 December 2025.
- 5) When the Terminal Services Contract has been signed and the contractual obligations (such as provision of a Bank Guarantee) for starting to use the terminal services are fulfilled, the applicant can start using Hamina LNG's services from 1 January 2026 onwards.
- 6) Hamina LNG will provide login information to the customer portal and other relevant systems required for services that the Terminal User intends to use.
